All pupils, in all year groups should return to school full-time from the beginning of the Autumn Term 2020. The Actions for schools during the coronavirus outbreak from the start of the autumn term is intended to support schools, both mainstream and alternative provision. It applies to primary, secondary (including sixth forms), infant, junior, middle, upper, school-based nurseries and boarding schools. Independent schools are expected to follow the control measures set out in this document in the same way. The guidance also covers expectations for children with SEND, including those with education, health and care plans, in mainstream schools.

There are additional risk assessments to cover specific activity, including a Covid-19 Boarding Risk Assessment. All relevant risk assessments can be accessed via the Staff Handbook under the Health & Safety section in the file marked 'Covid-19'.

In the event of a boarding house being in isolation because of a positive case in the house, then the pupils will wear face masks in communal areas. In this case, boarders will not be required to wear face masks in their rooms. During normal term time, boarders will not be required to wear face coverings in their boarding house unless instructed by staff to do so. Everyone will be reminded to wash their hands before leaving the House and on arrival back into the House in the evening. The 'catch it, bin it, kill it' approach will continue to be emphasised. E. Poor response to a symptomatic boarder or to a positive case in the boarding community.	5	3	15	 Covid-isolation wing on the Health Centre where possible and the boarding house to which they belong will be put into isolation. Arrangements will be made for the feeding and care of the symptomatic pupil and the boarding house in question. A symptomatic pupil will be tested with the lateral flow test. If they are negative, then we will test the pupils in the same dorm and those with whom they have been in close contact. The symptomatic pupil will still have a PCR test and will remain isolated until the result of that test is known. If either the lateral flow test or the PCR test are positive, then the relevant boarding house will isolate as per the guidelines and contacts of that pupil will be traced and isolated. Pupils in the same dorm will be tested with a lateral flow test. Advice from Public Health, Wiltshire has made it clear that a positive case in a boarding house means that the boarding house should isolate for 10 days, as they are regarded as being a household. Public Health, Wiltshire also confirmed that staff may come and go from the boarding house, but the number of staff should be kept to a minimum and they must keep a 2-metre distance from the pupils and wear appropriate PPE. 				 Adequate staffing has been retained during the period of national lockdown to ensure the thorough and appropriate cleaning of areas of the School still being used. The laundry will also continue to run. The housekeeping department is fully staffed again from 8 March to reflect the return to full re-opening. Cleaners wiil be using standard cleaning products, paying attention to all surfaces but especially ones that are touched frequently, such as door handles, light switches, work surfaces, remote controls and electronic devices. For cleaning areas where a person with possible or confirmed coronavirus (COVID-19) has spent time/passed through, refer to the separate Stonar Cleaning during Coronavirus Pandemic Risk Assessment. All bins, where possible, will be lined and the liner removed at the end of the day, sealed/knotted and placed in the main waste containers. Ensure disposable wipes, disinfectant spray and disposable tissues are available in boarding houses. Ensure arrangements are in place for the disposal of clinical and general waste where required. Plan for the removal and safe disposal of rubbish. Ensure that pupils can have clothes laundered reguarly both in the school laundry and in the Houses. Ensure that face coverings are washed safely and regularly and that pupils are changing their face coverings to allow for washing.
